- I. Call to Order Chair Jason Chang
 Chair Chang called the meeting order at 2:28pm.
- II. Approval of Minutes from August 5, 2019 Meeting
 - Chair Chang entertained approval of the minutes. Rodney Lee motioned to approve. Tim Wong seconded. Unanimously approved.
- III. WIOA American Job Center Certification Tool due to the Workforce Development Council by January 15, 2020
