I. Call to Order

The Full Board meeting was called to order at 8:31 am by Chair Jason Chang.

II. Welcome and Introductions

(Note: Per the State OIP, OWDB members are allowed to attend board meetings on audio only. Their votes will still count, and their attendance will also count toward quorum. However, board members must state their names clearly during introductions and before all of their comments during the meeting.)

Chair Jason Chang introduced new OWDB staff member, Daven Kawamura. Jason also introduced newest OWDB board member, Jeff Wagoner. Jeff is the President and CEO of Outrigger Hospitality Group.

III. Approval of Minutes

a. October 19, 2023 Meeting Minutes

Chair Jason Chang requested a motion to approve the minutes for the October 19, 2023 meeting. Christopher Lum Lee moved to approve the minutes. Pat Anbe seconded the motion. There were no objections or abstentions. The minutes were unanimously approved.

V. Update on Sector Partnerships

Keala Peters, Executive Vice President of Education & Workforce Development and Executive Director of Sector Partnerships at the Chamber of Commerce Hawaii, presented updates on Sector Partnerships. The presentation can be found at the following link:

Jeff Wagoner, President and CEO of Outrigger Hospitality Group, wanted clarification why hospitality is not a sector being focused on as it has an aging workforce, high paying job, and a void in leadership that has been forming in Hawaii. Keala let Jeff and the board know that the sectors were determined by the "Talent Roadmap for Hawaii" that was drafted in October 2020. The roadmap looked at where the largest growths were and how to support the future growth.

VI. Reallocation of up to \$3MM of funds

Christopher Lum Lee, Chair of the Oahu Workforce Development Board Finance Committee, presented on the reallocation of up to \$3MM of funds. The presentation can be found at the following link:

Carla Kobashigawa, Director of Applied Computer Training & Technology, Inc., brought up the relation between program years, expenditures, and the returned funds that was talked about during the Finance Committee meeting. Although it is calendar year 2024 funds from PY22 can and will need to be used prior to using PY23 funds. The lapse in funds is continually happening over the program years, therefore only having four quarters instead of eight quarters to spend down funds. Nicole Anderson added that at the meeting, performance measures were proposed to have a standard for a possible reassessment during the quarter.

Per the slide deck that was shared, Carla Kobashigawa wanted clarification on why the allocation will be coming from the particular programs stated (Adult, Dislocated Worker, and Youth) and why the projected ~\$2.2MM return differs from the proposed amount of up to \$3MM.

- Chris stated that the \$3MM amount takes into account the possibility of disallowable costs and a buffer for the lower than projected spending in the month to month expenditure reports.
- Raymond Duong, Budget Analyst for the Oahu Workforce Development Board, let the board know that there are possible consequences for continually returning funds and not meeting performance measures. If the board is sanctioned the following could happen: withholding of up to 5% of the boards WIOA title I funds, decertification of the board, and removal of the service provider.

Harrison Kuranishi let the board know that a sanction policy came out February of 2022. If PY23 funds (already started on July 1) are not fully spent down the possible consequences of the board being sanctioned listed above can happen.

Chair Jason Chang requested a motion to withhold up to \$3MM of funds. Christopher Lum Lee moved to withhold up to \$3MM. Jeff Wagoner seconded the motion. Frederick Pascua and Carla Kobashigawa abstained from the vote. The motion was approved.

Harrison Kuranishi clarified that the withholding of funds will not be permanent and will only be withheld temporarily until the funds are spent down and are caught up.

VII. Reports Related to WIOA

a. One Stop Operator

Andrea Gaines, Assistant Administrator of the WorkHawaii division, went over the One Stop Operator report.

Carla Kobashigawa wanted clarification on what the "customer count" that is provided exactly consists of and if it's possible to get not only the one quarters amount but a count for the full program year that the funding being utilized is from. Andrea stated that the number is the individuals that are utilizing the center.

• Harrison Kuranishi let Carla know that the customer count being presented will be everyone, not specifically individuals that are eligible for Title I programs. The data from the WIOA Title I report will have more pinpointed numbers.

b. WIOA Title I Programs

Leina'ala Nakamura, Administrator of the WorkHawaii division, went over the WIOA Title I Programs.

Christopher Lum Lee wanted to know if it was a possibility to get a breakdown of the individuals receiving support services, individualized career services, training, and/or on-the-job training. The breakdown for PY22 can be pulled from HireNet up to September 30th, the December 31st data available sometime in February.

Reginald Dela Cruz, an instructor and coordinator for the Project SEARCH program, wanted to know if there was any outreach into the schools to disseminate information for the program. Nisa Tokunaga started working with Leeward coast, and will be attending the monthly meetings of all the high school counselors on the Leeward coast.

Nicole Anderson, Workforce Development Program Manager for the Office of Economic Revitalization, wanted to know the thought process of expanding services into the libraries specifically on how it will reach the qualified populations. Leina'ala stated that in prior meetings the libraries kept coming up in conversation as it is a free community resource that many individuals that go to for services. Although no progress has been made yet, if successful it'll be easily transferable to the other counties.

b. Institute for Higher Education, UH System

Dan Doerger, Director of Workforce Innovation for the University of Jason Community Colleges, gave an update on the Good Jobs Hawai'i grant.

c. Vocational Rehabilitation

Pina Lemusu, Temporarily Assigned Oahu Branch Administrator at the Division of Vocational Rehabilitation, gave an update for the Division of Vocational Rehabilitation.

d. Wagner-Peyser

Erick Pascua, Oahu Branch Manager for Department of Labor and Industrial Relations Workforce Development Division, presented updates for the Wagner-Peyser program.
