I. Call to Order

The Performance Measures and Accountability Committee meeting was called to order at 1:00 pm by Committee Chair Suzie Schulberg.

III. Approval of Minutes

a. September 28, 2023 Meeting Minutes

Chair Suzie Schulberg requested a motion to approve the minutes for the September 28, 2023 meeting. The meeting minutes of the June 14, 2023 meeting were sent out

with the invitation. The approval of the September 28, 2023 meeting minutes were deferred to the next meeting.

- Chair Suzie Schulberg brought up the "Measurable Skills Gain" performance measure being considerably low.
 - Harrison Kuranishi, Executive Director of the Oahu Workforce Development Board, let Suzie know that it is most likely due to a lack of inputting. As it is difficult to get a credential, another tracked performance measure, without a measurable skills gain.
 - Dan Doerger, Director of Workforce Innovation at the University of Hawaii Community College system, echoed Harrison. He stated that there is a similar problem at the University of getting statistics inputted.

V. Announcements and Public Testimony

Harrison Kuranishi let the committee know that after the agenda had been circulated, the responses to the monitoring have been received. There were ten findings that were closed, but there are twelve that are still open. The twelve that are currently open are easily fixed.

Harrison also stated that the board will be doing the monitoring for the service provider by March 31st. The state will likely monitor the board shortly after followed by the Feds.
